# DEMOGRAPHICS

#### Population of Children Under Age 20

#### Percentage of Children Under Age 18 Living in Low-Income Families

The percentage of children birth through age 17 who live in families with incomes below 200 percent of the U.S. poverty threshold, as issued by the U.S. Census Bureau. The federal poverty definition consists of a series of thresholds based on family size and composition and is updated every year to account for inflation. In calendar year 2018, a family of two adults and two children fell in the "low-income" category if their annual income fell below \$50,200. The data are based on income received in the 12 months prior to the survey. Small area regional rates were used for the 27 smallest counties not included in the American Community Survey.

#### CHILDREN'S HEALTH

#### Percentage of Uninsured Children Under Age 19

The percentage of children birth through age 18 not covered by any health insurance. The data are based on health insurance coverage at the time of the survey; interviews are conducted throughout the calendar year. #### Percentage of Children Under Age 19 with Medicaid Coverage

The number of children birth through age 18 participating in Medicaid (MA) divided by the population of children birth through age 18, as estimated by the Pennsylvania State Data Center.

#### Percentage of Children Under Age 19 with CHIP Coverage

#### EARLY LEARNING

#### Children Under Age 5 Eligible for Subsidized Child Care

This measure originated from the "Child Care Works in Pennsylvania, 2018" mapping analysis and was most recently updated with the "Child Care Works in Pennsylvania 2020" maps and fact sheets. Estimates of the number of children under 5 years needing care were derived by multiplying the percent of children under 6 years who have all available parents in the labor force by the estimate of children ages 0-4. This number was then multiplied by the percent of children under 6 years living in families with income below 200 percent of the U.S. poverty threshold, as issued by the U.S. Census Bureau, to estimate the number of children eligible for Child Care Works (CCW).

The percentage is derived by dividing the number of eligible infants, toddlers and preschoolers not enrolled in Child Care Works by the estimated number of children under 5 years eligible for subsidized child care.

The percentage is derived by dividing the number of child care providers designated as Keystone STAR 3-4 and/or accredited by the Association of Christian Schools International (ASCI), National Association for the Education of Young Children (NAEYC), the National Association for Family Child Care (NAFCC), National Early Childhood Program Accreditation (NECPA) or Montessori by the number of child care providers serving children under five years.

# Percentage of Children Age 3-4 in Publicly Funded, High-Quality Pre-K

This measure originated from "A Smart Choice for a Solid Start: The Case for Pre-k in PA" report and was most recently updated with the "High-Quality Pre-Kindergarten in PA 2020" maps and fact sheets. The percentage is derived by dividing the number of children age 3-4 participating in high-quality, publicly funded pre-kindergarten programs by the population of children age 3-4, as issued by the U.S. Census Bureau. Publicly-funded pre-kindergarten includes federal- and state-funded Head Start, school district pre-kindergarten, Child Care Works enrollments in Keystone STARS 3 and 4 facilities, Philadelphia pre-k in Keystone STARS 3 and 4 facilities. and Pre-K Counts.

The percentage of children ages 3-4 who were not enrolled in Head Start (federal- and state-funded), school district pre-kindergarten, Child Care Works in Keystone STARS 3 and 4 facilities, PHLpreK in Keystone STARS 3 and 4 facilities or Pre-K Counts and who live in families with income below 300 percent of the U.S. poverty threshold. The pre-kindergarten eligibility threshold is 300 percent. ### Child Protective Services (CPS) Referrals

#### General Protective Services (GPS) Referrals

#### Children Receiving In-Home Services

This measure is pulled from the 2020 State of Child Welfare dataset. The number of children receiving services in their home to address issues of abuse and neglect.

# Percentage of Children Re-Entering Foster Care Placement

This measure is pulled from the 2020 State of Child Welfare dataset. The percentage of all children who were discharged to reunification with their parents or other relatives before their 18th birthday in a 12-month period, and subsequently reentered foster care in less than 12 months following their reunification. Young adults up to age 21 are counted as a re-entry if the initial discharge was before they turned 18, and reunified with their parents or other relatives. #### Enrollment

#### English Language Learners Rate

#### Poverty Rate (<185%)

The percentage of children ages 6-17 that live with families earning less than 185 percent of poverty, as issued by the U.S. Census Bureau. The Basic Education Funding Formula enacted in 2016 includes student-based factors on the percent of children in acute poverty (0-99%), poverty (100-184%) and concentrated poverty (≥ 30% living in acute poverty). **Source:** U.S. Census Bureau, American Community Survey, 2014-18 (B17024)

#### Proficiency

The percentage of public school students who met the proficient or advanced level as measured by the Pennsylvania System of School Assessment (PSSA). Proficiency levels are provided for third grade students in English Language Arts and eighth grade students in Math.

# Four-Year Cohort Graduation Rate

The number of on-time graduates divided by the number of first-time entering ninth grade students who entered four years earlier. Adjustments each year for students who transfer in and out are included in the calculation. A rate is determined for all public high schools, comprehensive career and technical centers and charter schools that graduate students from twelfth grade.
