

CHILD PROTECTIVE SERVICES (CPS)

Child maltreatment is a serious problem that has grave and costly consequences for the child, his or her family and the community at-large. A child who has experienced abuse and neglect is more likely to have social, emotional and physical health problems and perform poorly in school.

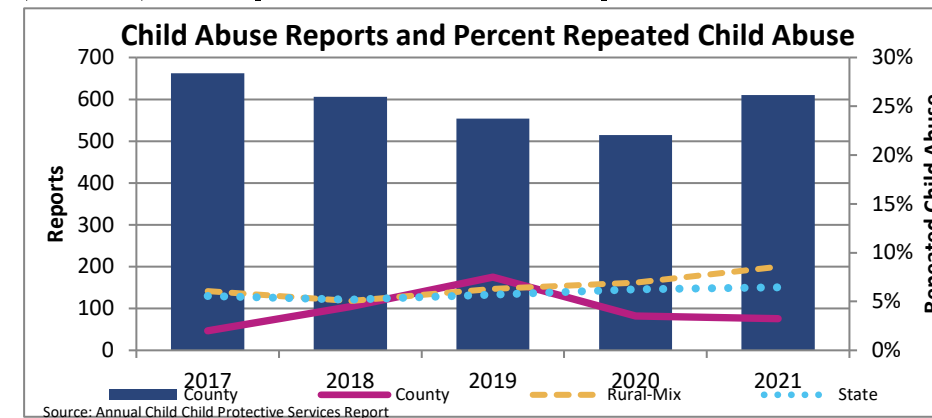
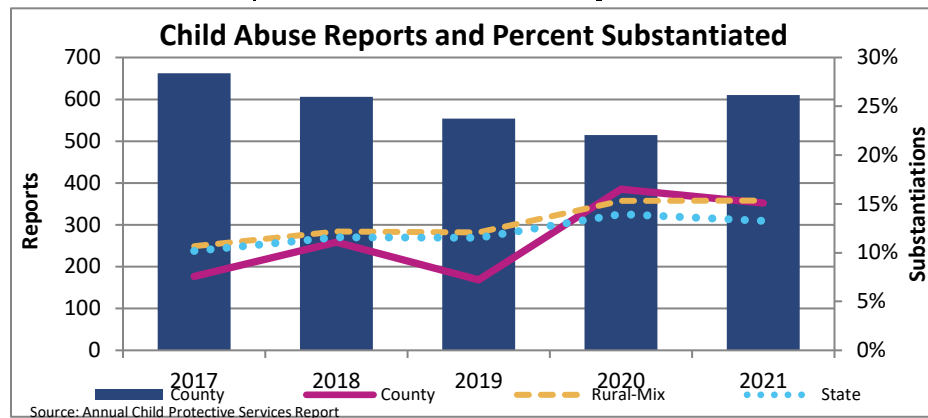

Reports not alleging abuse of a child are categorized as general protective services (GPS) reports. Addressing concerns related to child safety and well-being before allegations of child abuse or severe neglect are made enables children to remain safely in their own homes while services are provided to the family to mitigate the risk of potential maltreatment.

FOSTER CARE - SERVED

Foster care is meant to be a temporary intervention to assure the safety and well-being of a child. A child who spends long periods in foster care is more likely than other children to drop out of school, have mental health challenges, and experience unemployment and/or homeless as an adult. 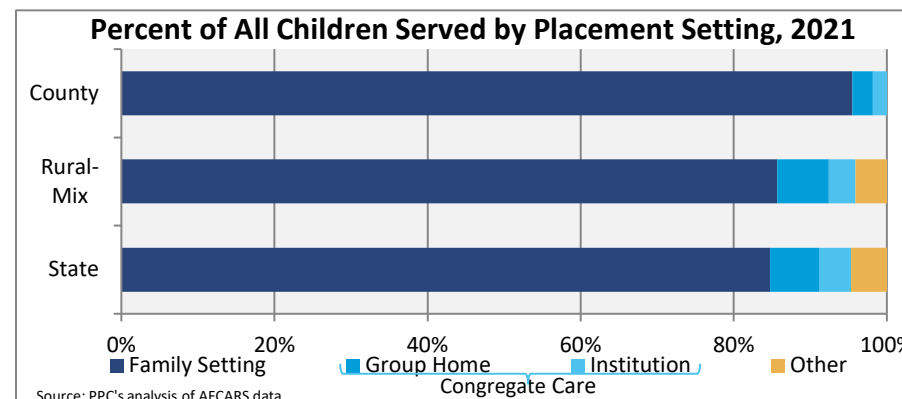

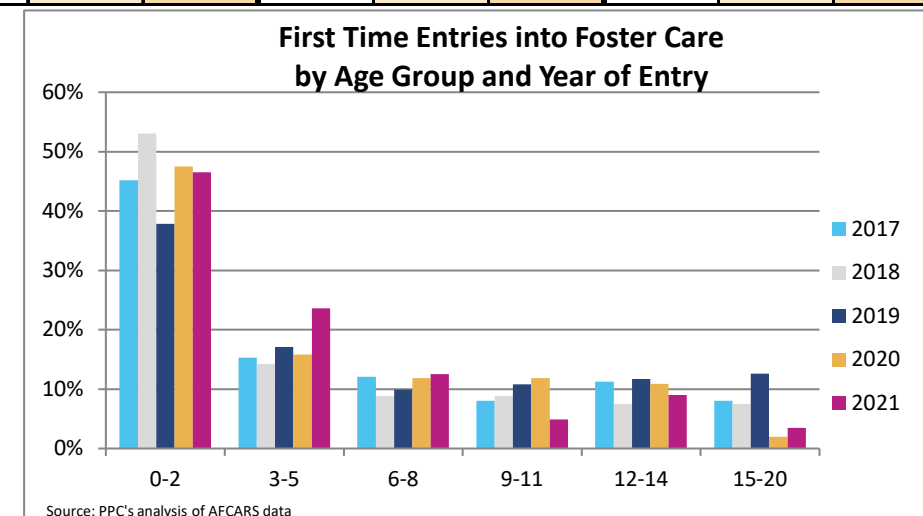
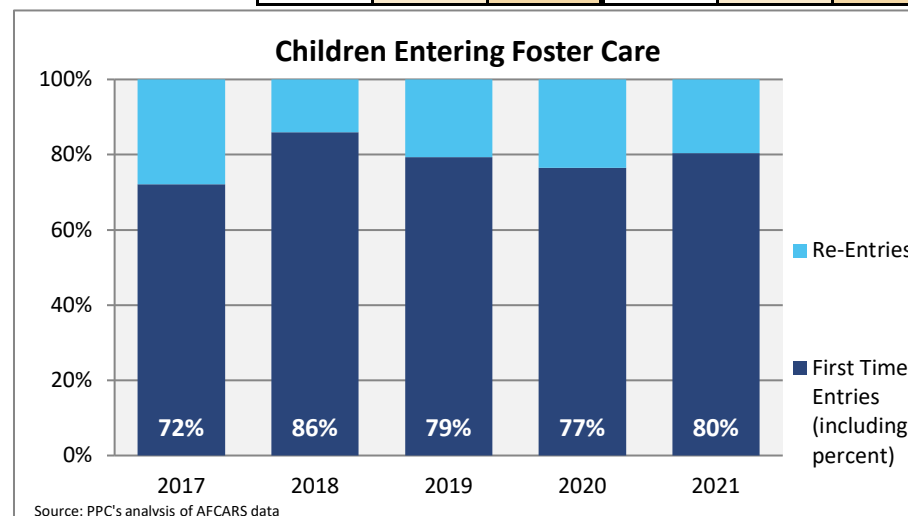

Some children experience numerous foster care episodes or cycle in and out of the system. Others can experience large spans of time between foster care episodes, which is why the age of children who re-enter is typically older.

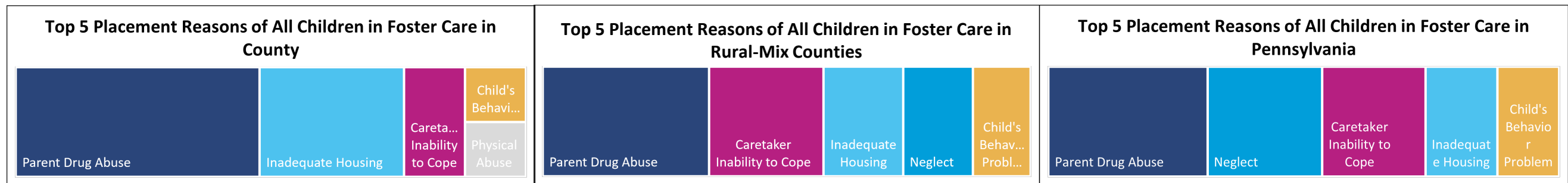

In addition to the court-ordered 'primary' goal, a 'concurrent' goal is put in place to ensure permanency is achieved if for some reason the primary goal cannot be met. This data provides information on the most recent primary goal for every child served in foster care during the federal fiscal year.

Children who re-entered foster care in fewer than 12 months following reunification with parents or relatives.

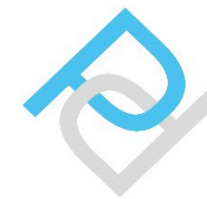
