



### **CHILD WELFARE**

**BLACK CHILDREN, HISPANIC CHILDREN** AND CHILDREN OF **MULTIPLE RACES** have disproportionately higher rates of CPS referrals, including substantiations and valid GPS allegations

children and youth served in the foster care system

children and youth in foster care placed in congregate care settings

youth in foster care are placed with kin

foster care were reunified with their parents or kin within 12 months

#### **EARLY CARE AND EDUCATION**

children enrolled in publicly funded, high-
