

## CHILD PROTECTIVE SERVICES (CPS)

Child maltreatment is a serious problem that has grave and costly consequences for the child, his or her family and the community at-large. A child who has experienced abuse and neglect is more likely to have social, emotional and physical health problems and perform poorly in school.

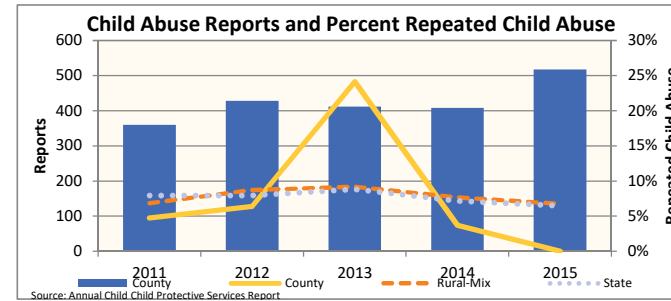
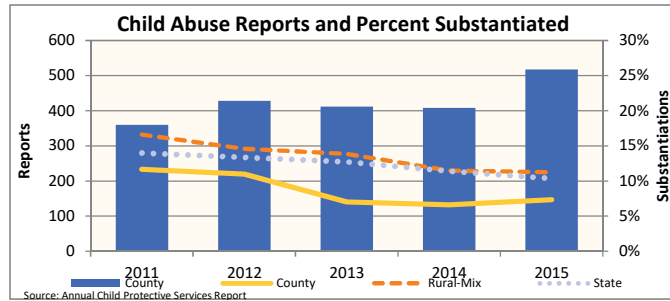

## GENERAL PROTECTIVE SERVICES (GPS)

Pennsylvania has a differential response system in that reports not alleging abuse of a child are categorized as general protective services (GPS) reports. Addressing concerns related to child safety and well-being before allegations of child abuse or severe neglect are made enables children to remain safely in their own homes while services are provided to the family to mitigate the risk of potential maltreatment.

### Indicator

#### GPS Reports

Total reported concerns of general neglect, not alleging child abuse. General neglect concerns may include parental substance abuse, inadequate shelter or supervision, parent-child conflict or truancy concerns.

## FOSTER CARE - SERVED

Foster care is meant to be a temporary intervention to assure the safety and well-being of a child. A child who spends long periods in foster care is more likely than other children to drop out of school, have mental health challenges, and experience unemployment and/or homeless as an adult. 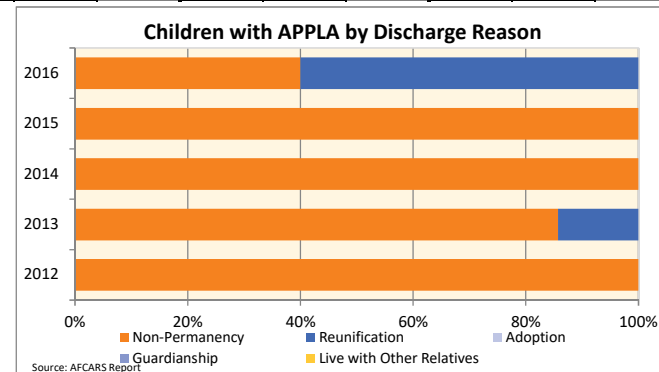
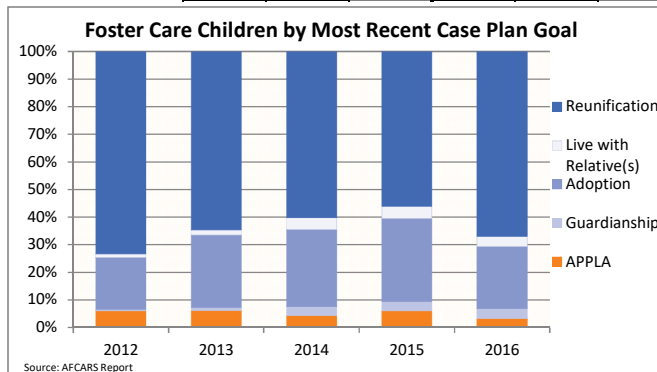
## FOSTER CARE - GOALS

Every time a child moves, the trauma caused by separation and lack of continuity grows. A child who faces multiple placements struggles to build and maintain healthy relationships and confront academic challenges due to school changes.

Children who were in foster care for 12 to 23 months and had three or more placement settings.

## FOSTER CARE - TIMELY REUNIFICATION

Children who entered foster care for the first time who were reunified with their parents or discharged to relatives within the next 12 months.
